Dated:29-01-2024 FOR PREPARATION OF PSDP 2024-25**

DECISION

The National Economic Council considered the summary submitted by the Ministry of Planning, Development & Special Initiatives dated 26th January, 2024 titled "**Proposed priorities and guidelines for preparation of PSDP 2024-25**" and approved the proposals contained at para 2 of the summary.

II. The NEC directed Ministry of Planning, Development & Special Initiatives to review and improve the poverty assessment criteria for selection of least developed districts for PSDP funding, to make the criteria more objective and equitable, and to submit the revised criteria to the ECNEC for consideration and approval.

III. The NEC also directed Ministry of Planning, Development & Special Initiatives (PD&SI) to include all districts of Balochistan except Quetta and newly merged areas of Khyber Pakhtunkhwa as well as Kohistan in the list of least development areas for PSDP funded projects.

IV. The NEC further directed that all provinces shall allocate funds in their ADPs for water related development projects in the light of National Water Policy and to share the implementation status every quarter with the Ministry of Planning, Development and Special Initiatives for placement before the NEC.
